The Swiss National Anthem

The Federal Council has finally designated the original version of the «Swiss Psalm» by Zwysig/Widmer as the official national anthem for the Army and for Swiss diplomatic circles abroad.

This decision brings to an end many years of efforts to achieve a state-recognized national anthem. As the Federal Council has no legal basis for imposing a national anthem on the cantons, it can only declare the «Swiss Psalm» obligatory for the Army and the diplomatic missions. However, it has sent a letter to the cantons recommending them to adopt the anthem too.

The «Swiss Psalm» was first declared the official national anthem, on a trial basis, in

1961 to replace the song «Rufst Du mein Vaterland» («O monts indépendants»), which had been used for that purpose. The change was made mainly because it had the same tune as other national anthems.

In 1975 the Federal Council ended the provisional nature of the new anthem. But as the German text of the «Swiss Psalm» seemed to present problems, it instructed the Department of the Interior to examine the possibility of a revised version.

The result was that none of the numerous texts proposed offered the same advantages as the original German version of the «Swiss Psalm», a song familiar to all sections of the population and all regions of the country,

dignified and solemn, conforming to the idea of a national anthem held by the majority of our compatriots.

In view of the 20-year tradition and the widespread approval of the population, the Federal Council felt the time had come to take a final decision. In doing so, it is also acting upon a recommendation from the Union of Swiss Choirs («Union suisse des chorales»/«Schweizerische Chorvereinigung»), the umbrella association of our country's amateur choirs.

Got, the Lord, in our Fatherland.

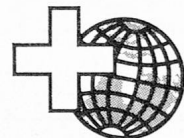

Increase of AHV/IV of the 1/1/1982

The Federal Council has decided to adjust the old age insurance/invalid insurance pensions to the development in Swiss wages and prices. The increase will be between 12,2 and 13,1 percent. Some recipients, who can claim only partial pensions because of an incomplete period of payment, will receive a smaller increase or none at all. According to the 9th revision of the regulations (introducing a new and finer scale in the partial pension system), they are actually receiving amounts which are too high. If the adjustment results in a lower amount than one has been receiving so far, the pension will remain unchanged (so-called level of possession guarantee).

Together with the pensions, the Federal Council has increased other amounts and scales in the AHV/IV system. For example:

- The upper limit of the sinking contribution scale for self-employed to sFr. 29 800.- (previously 26 400.-).
- The minimum contribution for self-employed and non-earners to sFr. 235.- a year starting in 1982 (previously 200.-).

Appeal

to notify Swiss property in Morocco

On 5th February 1981, the Agreement between the Swiss Confederation and the Kingdom of Morocco concerning settlement of the financial consequences resulting from the transfer to the Moroccan State of agricultural goods or goods for agricultural usage belonging to Swiss citizens came into force.

According to the Agreement, Morocco paid the Confederation a lump sum amounting to 2 000 000.- Swiss francs in compensation for Swiss property, rights and interests in Morocco affected by the transfer to the Moroccan State of ownership of agricultural property or property for agricultural usage. The Federal Council has appointed the Commission for foreign indemnity to apportion the lump sum without prejudice to the right of appeal. Swiss parties concerned (natural or juridical persons) who believe they can claim in accordance with the above Agreement, must notify their claims to the

Notification of claims must reach the Commission not later than 31st January 1982. This date is final and the Commission will not be able to consider any notification made later.

Interested parties who were notified of the signing of the Indemnity Agreement with Morocco by the Federal Department of Foreign Affairs in a letter of 3rd October 1978, are considered as having notified their claims and are not required to renew them.

It is in the interest of the parties concerned to provide the Commission as soon as possible with all the necessary informations regarding their case, in particular, name, civic rights, company name, lot number, extract from the register of real estate.

N. B. Sponsorship is not limited to people living in Switzerland. Swiss abroad often act as sponsors for their children.
