Citizenship Campaign




In view of the decision by the Swiss people and the Cantons on 4th December 1983, we feel extremely gratified; it is now possible that Swiss women abroad will be put on an equal footing with Swiss women in Switzerland with regard to passing on Swiss citizenship to their children. The Organization of the Swiss Abroad and its Secretariat have contributed considerably to this development, first in the initial phase befor the parliamentary consultation, and then by providing information continuously in the course of these years, and finally during the plebiscite campaign.

Those particularly interested already know the result of the voting, but we wish to give you hereby a few more details:

a) Voting participation was much the same as during the past few years, viz **35,3%**. In view of the preceding elections to the National Council, participation could really be called satisfactory. b)Results according to Cantons where the introduction of equality in citizenship is concerned:

c) Geographical presentation of the results:



The plebiscite was concerned with several changes in the Constitution; Art. 44, par. 1 reads:



«The Confederation regulates acquisition and loss of citizenship rights by origin, marriage and adoption, as well as loss of Swiss citizenship and its reinstatement.»

On the basis of these changes, commissions will be formed which will work out the applicable legislation. As a first subject, the transmission of Swiss citizenship by a Swiss mother married to a foreigner will be considered: this was affirmed on the evening of the plebiscite by Federal Councillor Friedrich, Head of the Federal Department of Justice and Police. We shall follow the progress of these preparations with great interest and shall keep you informed on the progress and on possible steps to be undertaken. We may count on the law coming into force in 1985. Until this is the case, Swiss authorities are in no position to make any changes in the citizenship regulations, and it is therefore useless to approach them regarding this question. Legislation concerning acquisition

of Swiss citizenship by a foreign spouse of a Swiss woman or man will probably take more time, as fundamental questions have to be solved in this matter.

On 4th December 1983, a second constitutional change was proposed to the Swiss electorate: facilitated naturalization of young foreigners grown up in Switzerland, as well as refugees and stateless persons. The voters rejected this proposal with 793045 against and 644537 for (55,2% against). We regret this decision, specially because Swiss abroad are very often foreigners in their country of residence, and sometimes reciprocal rights can be of great importance.

Commentary

The revision of a Constitutional Article is a lengthy undertaking which requires ideas, studies, inquiries, definition of needs, editorial work and press campaigns; the Message has to be defined. Our efforts began as soon as the relevant modalities concerning Swiss women in Switzerland were published in 1976. They go back to the initiative of a Swiss lecturer resident in Great Britain, who collaborated closely with the Secretariat of the Swiss Abroad. An appeal as well as an extensive inquiry in 1979 brought us confirmation that we were on the right track; for of the 2700 answers received, 95% were in favour of Swiss women living abroad to be able to pass on Swiss nationality to their children. In the course of the following years, no fundamental opposition to this attitude came to our ears; only with reference to procedure with the revision, different opinions were voiced. Basically, the most important point was to get the change as quickly as possible and with the least chance of failure, and that was why eventually a simple change in the legislation was proposed rather than a constitutional revision.

The wish for a simple legislative change was thwarted by Article 44 of the Federal Constitution. The Organization of Swiss Abroad, therefore, decided to launch a Parliamentary Initiative which, as we now know, has led to success.

In order to further these interests of Swiss women abroad, that Swiss lecturer resident in Great

Britain formed a number of groups with the interested people who had expressed a favourable opinion in the inquiry. In this manner, a widely-cast net of contacts by correspondence with the Secretariat was established, which also resulted in a rich source of ideas and general agreement with the activities of the Organization of the Swiss Abroad. Unfortunately, someone in France openly declared himself «heir» to the lecturer in Britain, now dead for two years, and sent a number of articles to several Swiss dailies during the plebiscite campaign of November 1983, in which he demanded the rejection of the constitutional revision and with it the exact opposite of what the campaign intended. As he was unsuccessful in the plebiscite of 4th December last, he subsequently approached the cantonal Governments and demanded an annulment of the federal plebiscite on the revision of the citizenship laws.

This action is hardly understandable, for after the constitutional revision, we now have to make the necessary legislative changes, which will be started this year. Also those people who originally wanted a simple change in legislation only, should now surely have the same concern as the majority of the Swiss electorate after its decision of 4th December 1983.

All our efforts are concentrated on this legislative change. It will need our full attention so that no new discriminations will emerge.

The Swiss Abroad and the United Nations

With the Assembly of Swiss Abroad in 1983 in view, the Secretariat of Swiss Abroad in Berne distributed a questionnaire to their compatriots abroad, in order to stimulate them to think more intensely about the question of Switzerland's full membership of the United Nations.

860 Swiss institutions abroad and official Swiss representations were approached,

and 207 of them replied. With this publication (with a world-wide circulation of 208000 copies) the questionnaire reached basically all registered Swiss abroad in June 1983.

By the 15th August, the Secretariat had received 3852 answers, 2262 no, 1368 yes and 222 abstentions. This means a rejecting majority among the Swiss abroad of 58.7% against to 35.5% for. The answers from the institutions with 52% against and 35% for are much the same proportion.

(An opinion poll amongst the Swiss at home in the «Weltwoche» of 10th August 1983 showed a majority against of 41% and 33% for).

From 33 countries, more than ten votes each were received. Of these, 21 countries were mostly against joining, above all USA, Canada, Italy, Great Britain and Australia. The results from Austria and Finland were indecisive. Ten countries showed a majority in favour: France, Western Germany, Norway and Sweden at the head.

The reasons for rejecting the proposal were above all the faulty system in the United Nations and the worry about Swiss neutrality. Those in favour gave as their main reasons the maintenance of an effective Swiss foreign policy and solidarity.

Many letters demonstrate the loyalty to the principles of Switzerland's democracy of our compatriots abroad, and that goes for those for as well as against Switzerland's accession. It is a loyalty not to be underestimated. The degree of information regarding the UNO question still needs improvement, although almost all Swiss abroad live in countries which are already members of the United Nations Organization.
