# Nurturing the next generation of scientists

**The Swiss National Fund supports the next generation of scientists with scholarships and exchange programmes. Swiss Abroad are eligible if they satisfy the requirements.**

The Swiss National Fund for the Promotion of Scientific Research is a private foundation dating from 1952. Its primary aim is to support untied basic research projects in all scientific disciplines. It has available some Sfr. 300 million a year.

Grants are reserved to people with Swiss citizen-

ship or permanently resident in Switzerland. Applicants require a university degree which can be the licentiate, diploma, state examination or a doctorate. Grants are intended to make possible a period of study abroad and may be had for any discipline. Importance is attached to the intention to return to Swit-

zerland. Grants are open to Swiss Abroad, both men and women, who meet the requirements.

For applicants in the first category "future researchers", at least one year's research work after the first degree is required. In some disciplines a doctorate is required. There is an age limit of 33 (with some exceptions).

In the second category, "advanced researchers", at least two years of research work after the first degree are

required. The work must have been successful, and led to publication. It is unusual to support anyone without a doctorate. There is an age limit of 35 (again with exceptions).

## Initiatives in brief

### “Work distribution”

The initiative “work distribution” has been launched by a left-green committee. With this popular initiative the following new provisions would be included in the federal constitution.

The federal government shall ensure that

- all men and women of working age are able to earn their living by paid work in appropriate conditions – in particular by a reduction in working hours and the pro-

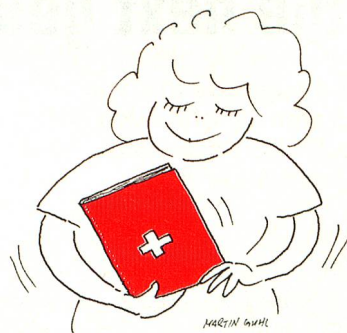
motion of various forms of work distribution;

- an equal distribution is possible between men and women without social or occupational disadvantage of socially necessary non-gainful work as well as service in the general interest;

- all persons of wage earning age may obtain occupational further training or conversion.

### Fees according to the Nationality Law



Those who apply for naturalisation from abroad must pay a fee of SFr 270.– for easier naturalisation or for renaturalisation. This is made up of the federal fee (SFr 220.–) and the fee of SFr 50.– for the canton of

origin for the preparation and provision of marital status papers.

If two under-age children make an application at the same time the fee amounts to SFr 190.– per decision (with SFr 25.– going to the canton in each case). For additional under-age children who apply at the same time, no fee may be levied.

Pursuant to article 5 of the List of Fees the fees may be reduced or waived for persons on low incomes.
