*Last ASR meeting*

**As your retiring delegate had just completed a stint of 35 years of being one of the voices speaking for Swiss in Southern Africa, a presentation was shown by him at the last March ASR meeting in Berne, highlighting the changes that had taken place during this period.**

ASR President Eggly paid tribute to the Southern African contribution. For a copy of it please contact Peter Müller. Your delegate had also invited the new nominees, Marcie Bischof and Hans-Georg Bosch. Unfortunately, Mr. Bosch was unable to attend, but Mrs. Bischof was applauded to succeed the undersigned. In consultation with the aforementioned new delegates, it is proposed that a small apero featuring South African wine will be offered to

the new office bearers prior to lunch on 16 August.

On reaching 65 in September, Ruedi Wyder will be retiring as ASO & ASR Director after serving admirably for 26 years. As your delegate, I have not only come to value his friendship, but also his sage advice. He has noticeably changed the scope and depth of activities that ASO perform for Swiss Abroad. The undersigned would like to pay tribute to his tremendous contribution that he has given our community. The August meeting will elect a successor.

At the last meeting, an interesting presentation on Statistics was presented. It is interesting to note that in the 33 years since 1980, the total number of Swiss Abroad worldwide has increased annually, resulting in a doubling from 354 000 in 1980 to 716 000 at the end of

2012. The breakdown of this number at the end of 2012 is as follows:

Europe 61,8%, America 24,6%, Asia 6,4 %, Oceania 4,3%, Africa 2,9%.

At the end of 2012, the 11 biggest Swiss communities were:

France 186 615, Germany 80 715, USA 76 330, Italy 50 091, Canada 38 959, UK 30 452, Spain 24 157, Australia 23 633, Israel 15 970, Argentina 15 767, Brazil 14 976.

The 11 countries comprising Southern Africa, with a total of 11010 Swiss Abroad, does not rank amongst the top 12 communities worldwide.

Angola 96, Botswana 68, Lesotho 11, Malawi 18, Mauritius 634, Mozambique 166, Namibia 326, Zambia 108, Zimbabwe 260, South Africa 9 284, Swaziland 39.

The next ASR & Congress meeting will be held in Davos mid August. You are invited to attend. The theme of the Congress is "Switzerland and Globalization". The undersigned will be formally handing over his mandate to his elected successors, to whom he wishes a successful term of office. It has been a privilege and honour to represent you.

*Consular visits of the Regional Consular Centre Pretoria*

**After a first round of successful visits to the whole consular district last year, the Regional Consular**

**Centre is happy to offer Consular meetings again in Mauritius and Durban this year.**

Please take note of the following schedule:  
Kwazulu Natal (Durban) 11.-13.11. and Mauritius (Quatre Bornes): 18. - 20.11.

Swiss citizens will have the opportunity to apply for a Swiss passport but can also attend to any other consular business. Please use this opportunity to make direct contact with a representative of the Regional Consular Centre. Please check if and for how long your current Swiss passport is valid. As we cannot guarantee yet that the next visit will take place in 2014, we suggest that passports with a validity of less than 12 months by the end of November 2013 be renewed using the facility we offer on these visits, unless you already plan a trip to Pretoria. If you wish to order a new passport you have to present yourself personally at the meeting due to the biometric data that has to be registered. Swiss citizens registered in the country or province mentioned will receive a letter with detailed information about the venue a few weeks before the visit. It is, therefore, important that you register your current e-mail address and/or your postal address. You can do that by sending an e-mail to: southernafrica@eda.admin.ch .
