Message from the Consul General in Montreal

Dear compatriots,
The network of official representations of Switzerland in Canada has been altered considerably with the closure of the Consulate General in Toronto. In fact, as of July 15th 2013, the Consulate General in Montreal has taken over full consular and administrative services for the population of Ontario, Manitoba and Nunavut. As Consul General, I extend a very warm welcome to the residents of these two provinces and territory.

A large number of compatriots living outside the city centre of Toronto will not be overly affected by the reorganization as several consular procedures continue to be addressed by post or via the use of electronic communication. Most hit however are those living in the Toronto area who no longer have access to a physical office within close proximity. My aim is to ensure a smooth transition following the recent changes and to maintain the strong ties that the Swiss communities in Ontario, Manitoba and Nunavut have enjoyed.

I have recently participated in productive exchanges with several representatives of Swiss societies and businesses in order to develop innovative and effective methods to ensure the continuity of established contacts and good relations. I am confident that the results of our discussions will be most satisfactory.

I am also pleased to report that as early as 2014, I expect to initiate "Consular Days" in the Toronto area by using the new mobile biometric stations. Such visits will be promoted well in advance and will allow for the collection of biometric data outside the Consulate General in Montreal. The biometric data is necessary for the delivery of Swiss identity documents.

91st Congress for the Swiss Abroad August 2013 in Davos

The congress began with a reception and opening remarks by President Jacques-Simon Eggly Thursday evening. 96 delegates from around the world attended the Annual Meeting. First business of the day was the confirmation of the newly elected country delegates, the election of the OSA and *Swiss Review* executive and the recognition of a newly formed Swiss Society in the Republic of Czechoslovakia. Canada was represented by Eastern Canada Delegates Bruno Setz, Montreal/QC and Ernst Notz, Toronto/ON, and by myself, newly elected delegate Silvia Schoch for Western Canada.

The recent consular closures in North and South America were hotly debated, several delegates spoke up. Ernst Notz expressed concern with reference to the consular closing in Toronto: not only does it negatively affect the Swiss citizens living in his consular area, but the loss of Swiss image and presence across the world and the loss of support of political and economic activity between Switzerland and these countries impacts us all negatively at a time when Switzerland should increase its presence in a globalized world.

Electronic voting for the majority of the Swiss Abroad is supported by the Federal Council for implementation by the next Federal Election in 2015. After approval in the Nationalrat, on-line election of OSA country delegates is scheduled to be implemented for the next general election in 2017.

The draft for the national legislation for the Swiss Abroad, the *Bundesgesetz über die Schweizer Personen und Institutionen in Ausland* has been submitted for consultation by the Staatspolitische Kommission des Staenderates in May 2013. The draft was written by a SPKS sub-commission, based on a parliamentary initiative by Filippo Lombardi *Ständeratspräsident Kanton Tessin* in conjunction with the support of EDA *Eidgen. Departement für auswärtige Angelegenheiten*. The legislative draft includes substantial elements of the legislative draft of the OSA council from its meeting in August 2010. A revision of a pending inheritance tax agreement between France and Switzerland was elaborated on by the French ambassador to Switzerland, M. Michel Duclos, and a discussion ensued with the French delegates.

A presentation by the Director of Swiss Tourism, Jürg Schmid, indicated a 20% reduction of sports tourism in Switzerland and his emphasis on a stronger focus on building what individual strengths Switzerland has within a globalized world. In his words: *Besser = Infrastruktur x Qualität x Differenzierung x Leidenschaft.*

Hansjörg Trachsel, former Secretary of State and political director of EDA Franz von Däniken presented the topic of *Switzerland, globally, regionally, locally*. He characterized Switzerland as *Denkplatz-Werkplatz-Finanzplatz* (place of thinking/creativity, work and finance), with emphasis on training, education, R&D and all aspects of creative innovation. He spoke of countries as *lockere Gefüge in der globalen Welt* (loose associations in a global world). According to the diplomat, this means Switzerland needs to be strongly engaged in the UN and also anchored and in cooperation with other similar thinking organizations and nations. Particularly in Europe, where more than 400,000 Swiss make their home within the EU. Even so, Mr. von Däniken sees the local and national needs growing within the global internationalization, in that the national government retains meaning for the individual citizen through the issuance of passports, social- and health insurance and due to the Swiss consular closures in the world. He closed with the statement that the state has a dual function of cooperation with other nations while retaining its individual character for the citizen.

Mr. Rudolf Wyder, retiring OSA Director, gave an excellent overview of the Organization of the Swiss Abroad during his tenure of 25 years. He summarized the development and accomplishments to date and indicated his perspective on OSA objectives going forward in a globalized world.

The highlight of the conference was the final address to the OSA delegates by Federal Councilor Eveline Widmer-Schlumpf. Councilor Widmer-Schlumpf summarized the importance of the 5th Swiss in a globalized world. *'Quality, Stability, Integrity'* were the words she used to describe the Swiss financial market place and for all of Switzerland and its industries to know its qualities of high political stability, education and quality output. In her final remarks, Councilor Widmer-Schlumpf reminded us that as Swiss Abroad, each of us is an ambassador of Switzerland and that we each play a role in representing our homeland.

Next year's congress theme will be *Information Technology and Social Media* and will take place in the dual locations of Baden and Aarau.
