Federal Councillor visited South Africa

Johann N. Schneider-Ammann, head of the **Federal Department of Economic Affairs, Education** and Research EAER, led a joint economic and scientific mission to South Africa in September.

It was the first time since the creation of the State Secretariat for Education, Research and Innovation SERI at the beginning of the year, that a foreign mission led by the head of department, covered the topics of economic affairs, science, research and innovation with the aim of harnessing specific synergy potentials in these areas. The potentials in these areas. The delegation's main focuses were energy and environment. South Africa is Switzerland's most important trade partner and export market in Africa and is also a priority country for research Switzerland's most important

cooperation. Furthermore, the level of Swiss direct investments in the country amounted to over CHF 2.2 billion by the end of 2011, making Switzerland the fifth largest country of origin of foreign direct investment in South Africa.

The visit took place at the invitation of the South African Minister for Trade and Industry, Rob Davies. Federal Councillor Schneider-Ammann held discussions with minister Davies himself and science and technology minister, Derek Hanekom. Besides a successful Swiss-South African Business Forum in Cape Town, cohosted by the Department of Trade and Industry and the Swiss Business Hub in South Africa – the delegation also attended a series of meetings with companies and institutions in the fields of education, research and innovation. These included the Transport Management Centre in Cape Town, the

University of Cape Town, ABB, the Council of Scientific and Industrial Research (CSIR), GlencoreXstrata and Consol Glass. The visit was concluded with a tour of Constitution Hill, where the delegation got an impression about the painful past, as well as an introduction by former Judge Yvonne Mokgoro to the Constitutional Court. Federal Councillor Johann Schneider-Ammann and his delegation were very satisfied with the outcome of the visit, both professionally and personally.

After a first round of successful visits to the whole consular district last year, the Regional Consular Centre is happy to offer Consular meetings again in Mauritius and Durban this year.

Swiss citizens will have the opportunity to apply for a Swiss passport and can also attend to any other consular business.Please check if and for how long your current

Swiss passport is valid. As we cannot guarantee yet that the next visit will take place in 2014, we suggest that passports with a validity of less than 12 months by the end of November 2013 be renewed using the facility we offer on these visits, unless you already plan a trip to Pretoria.

If you wish to order a new passport you have to present yourself personally during the above mentioned dates due to the biometric data that has to be registered.

Swiss citizens registered in the country or province mentioned will receive a letter with detailed information about the venue a few weeks before the visit. It is, therefore, important that you register your current e-mail address and/or your postal address. You can do that by sending an e-mail to: southernafrica@eda. admin.ch.

Notice for dual nationals

Please be aware that the Swiss representations do not issue Schengen visas for dual nationals with citizenship of a Schengen Member State. Relevant is the citizenship only; it does not matter whether the applicant is in possession of an EU or Swiss travel document or not. If you are a national of a Schengen Member State and would like to travel to the Schengen Territory, you have to travel with your EU or Swiss travel document which do not require a visa.

All visa clients who want to submit their applications will need an appointment through an external service provider as from November 1st 2013. ASR to protest against the closing of more consulates

The ASO Congress in Davos was a most interesting event especially in view of the issues affecting the Swiss Abroad Community.

The number of Swiss living abroad has risen to above 715'000 persons and with that represents some 10% of the total Swiss population. The ASR Meeting centred on the issues of the "Auslandschweizergesetz", the implementation of evoting and the closing of ever more consulates in various countries.

Another issue discussed was the problems besetting the French ASO section, which is currently involved in an internal fight for electing ASR-Vorstand delegates. As a result, the ASR Vorstand will have no French representation until new delegates can be agreed upon.

The Auslandschweizergesetz, which is currently in the process of being formulated, will if remaining in the time schedule, be promulgated into law during 2015. It is basically a condensation of parts of various laws into a separate Auslandschweizer-Gesetz.

The e-voting trial was deemed successful and steps are underway to make this service available to most citizens living abroad during 2015. As it is the cantons which decide when and how, there could still be delays being encountered.

The ASR unanimously adopted a resolution to protest against the closing of more consulates. One of the main points stressed was the time, distance and cost of travel the Swiss Abroad have to endure to make us of consular services in some areas. A historic example of how effective the ASR can be is the fact, that due to a motion of the Italian ASO section, mothers with Swiss nationality can pass on their citizenship to their children, even if their husband is not a Swiss citizen.
