VALOUR OF NEUTRAL PRESS.

Rare are the cases when the foreign press publicly acknowledge that the carrying out of a truly neutral state policy of other countries is based upon the uncompromising spirit of independence and courage of the people. But it does happen, as is proven by the following observation of the special American correspondent on the Continent of the American daily "The Christian Science Monitor" in their issue of 12th September, 1942: "Few things show up the brave faithfulness to the tradition of the liberal press better than the outspokenness of Swiss and Swedish newspapers, despite their enormous difficulties."

To that we may add that the traditional spirit of independence, and the courage of the Swiss people, are no fair weather qualities. They deepen inwardly and grow stronger as the dangers confronting the country assume unprecedented proportions.
