"BEGINNING TUESDAY AUGUST 22 AUSTRALIAN PROGRAMS THREE HOURS EARLIER WAVES 25.08 and 23.14 PLEASE ADVISE COLONIES AND CABLE RESULTS."

From this our compatriots will learn, that the regular weekly broadcasts will be heard as from the 22nd of August on:

Wave length: 23.14 and 25.08 m.  
Time: 5-6.30 p.m. on Tuesdays and Saturdays.

We take this opportunity to remind members, that we have asked them repeatedly through this paper to let us have reports on the reception of these broadcasts, so that we may be in a position to inform the Swiss Broadcasting Corporation accordingly and we should be very pleased indeed if members would be good enough to drop a line from time to time to the Secretary or to the Swiss Consulate in Wellington in this respect.

One of the regular listeners informs us that she listens to a daily broadcast from Switzerland on the 45 m band at 6.30 a.m. and at 5.45 p.m. when news is given, and these broadcasts are received quite well.
