## NOTICE TO NEW ARRIVALS WITH CHILDREN

### New Zealand Social Security Family Benefit

Upon arrival in New Zealand a special application form should be procured from the nearest Social Security Office or Post Office, on which, **in addition** to the questions asked, the **date of arrival, name of ship and port of arrival** should be stated. When duly completed this form should be sent to the nearest Registrar of Social Security, Social Security Department, and it is desirable at the same time to enclose the family passports.

In order to qualify for the FAMILY BENEFIT, proof of the **DATE OF BIRTH** of child or children is necessary, and also an **ASSURANCE THAT THE FAMILY HAS IMMIGRATED WITH THE INTENTION OF LIVING PERMANENTLY IN NEW ZEALAND**. Payments commence immediately the afore-mentioned requirements have been fulfilled. The Family Benefit is 10/- per week for each dependent child under 16 years of age, and is paid in monthly amounts of £2/3/4. However, if the child attends school after that age the benefit is then extended to the age of 18 years, upon production of a certificate from the headmaster of the school stating that the child is actually attending school.
