FIGHT OVER LARGE TAXPAYERS


The battle is on between cantons to try to attract more large taxpayers. By lowering their tax rates, some cantons hope to "steal" a few big tax payers away from other cantons. Other actions considered by some cantons are elimination of death and gift duties.

Although the competition between cantons is of great interest to large taxpayers (some of whom have already changed their domiciles for this very purpose), too much competition can create a worsening situation for cantons which are loosing some of their best "customers". To make up for their loss, these cantons will have to raise the general level of their taxes, which will result in more taxpayers leaving: a Catch 22 situation which the affected cantons do not relish at all.


So a move is underway amongst the various local governments to try to keep the differences in tax levels between cantons to a minimum. Whether this move will succeed is by no means certain if we look at the typical example of the commune (Gemeinde) of Wollerau.

Wollerau is situated in the canton of Schwyz but lies high above the lake of Zurich in the area which is increasingly called the "Gold Coast" of Schwyz. Thanks to the new commuter railway line (S-Bahn) and the motorway, Wollerau is a mere 15 minutes from Zurich, where most of its rich inhabitants have their businesses.

Because the canton of Schwyz has no death or gift duties and because Wollerau is also lowering its local taxes, this little, almost unknown village has become the place of residence of thousands of Zurich people. From 2000, Wollerau's population has tripled to 6000 over the past few years and it continues to grow. By shifting their residence to Wollerau, Zurich people are saving themselves thousands of Francs in taxes and duties. Very soon Wollerau will replace Zug as the financial paradise of Switzerland.



BOCCIA PLAYING NOW POSSIBLE ALL YEAR ROUND IN ZURICH



The expert Boccia players can easily be recognised by their typical stance: hands on back, small towel in hand and intense concentration on the balls being played.

With the recent opening of a Boccia centre at the Letzigrund, this very popular Italian game can now be played all year round in Zurich. Four Boccia Clubs have pulled together to promote the creation of this new centre which provides six playing alleys on two levels plus a restaurant and several conference and club rooms. Boccia is very similar to the French game "Pétanque" which has become quite popular in New Zealand over the past few years.
