Congratulations Anna

Recently, Anna Blattler graduated from Waikato University with a Degree:
Doctor of Philosophy in Materials and Processing Engineering.

Anna was born and bred in Hergiswil (NW). After leaving school in 1975 she started training as a Laboratory Technician (Chemical) with Ciba Geigy in Basel for one year. This was followed by a three year course in Agricultural Chemistry. She married in 1979 and completed her final exams while breast-feeding her first son. In 1985 the couple, together with their two sons, came to NZ, having largely been influenced in their choice of foreign country by Anna's Uncle Robert, who at the time was farming near Te Aroha. Initially they intended to start up a beekeeping business. However, things didn't quite work out as expected. In order to make ends meet, Anna took on a job with IRD before becoming an analyst of Vitamins and Minerals in Milk Powder with the NZ Dairy Co. Subsequently, the NZ Dairy Board sponsored her to a Masters Degree in Science and Technology with the specific purpose of finding the source of aluminium in milk powder. During these studies she advanced to Laboratory Manager. In 1991 she graduated with a Master of Science and Technology Degree. At this point, the couple bought the Te Aroha Holiday Park. Once again, things didn't work out as planned - they separated, with Anna now running the business on her own. In 1996, Government funding made it possible for Anna to begin studying for a Ph.D by investigating pumice and iron sand for the application of waste water technology. With Waikato University and ETH Zurich working in tandem, Anna is very proud to have had her thesis checked out by an ETH professor who happens to be a world authority in this particular field. During her forthcoming trip to Switzerland, she hopes to, at last, meet up with her mentor.
