

Javnost—The Public, an interdisciplinary journal in social sciences emerges from a need to address problems of the public sphere on an international and interdisciplinary level, to stimulate the development of theory and research in the field, and to help understand and bridge the differences between different cultures. Its contributors confront problems of the public, public communication, public opinion, public discourse, publicness, publicity, and public life in general from a variety of disciplinary and theoretical perspectives.
