The London Swiss Philatelic Society met on Tuesday, April 27th, at their Headquarters, Swiss House, 35, Fitzroy Square, W.1, for their Monthly Meeting. Twenty Members were present. Five new Members were admitted and the Society now has a Membership of forty. The Hon. Packet Superintendent reported that 140 booklets were in circulation at the present moment.
