**SWISSAIR STARTS JET SERVICES TO SWITZERLAND.**

Daily pure jet flights to Switzerland started on Saturday, 21st May, with Swissair's introduction of Rolls-Royce powered Caravelles on the "Super Swiss" service between London and Zurich. There will be two departures from London daily, leaving at 11.30 a.m. and 7.05 p.m. Flying time between the two cities will be 90 minutes.

Caravelle night tourist services between London and Zurich are expected to start in July, subject to government approval being received. Until then night flights between the two cities will be operated with existing equipment.

From 15th July Swissair will operate daily Caravelle services to the Middle East. Destinations served will be Istanbul, Ankara, Cairo and Tel Aviv, all via Athens. Caravelle services between Switzerland and Scandinavia also start on 15th July, while Madrid, Lisbon and Vienna will be served by these jets from 16th August.

In all, Swissair is putting four Caravelles into service in the course of this summer. Except for all-tourist night services, they will offer twenty first and fifty tourist class seats.
