"LANDSGEMEINDE 1960".

For the twelfth consecutive year the third Sunday in June was earmarked for the "Landsgemeinde" of the Swiss in Lancashire and Yorkshire, held at Harcastle Crags in Yorkshire.

We gathered in the Memorial Gardens at Hebden Bridge and were welcomed to the district by the Chairman of the Hebden Royd Urban District Council, Councillor J. K. Wilcox, J.P., his wife and his two charming daughters. We were honoured also to meet our guests of honour Mons. J. J. de Tribolet, First Counsellor of Embassy, and Madame de Tribolet, representing H.E. Mons. Armin Daeniker, Swiss Ambassador, and Madame Daeniker.

Harcastle Crags is situated in the territory of Hepton Rural District, a stone's throw from Hebden Bridge. The beauty of this enchanting valley has been described already in reports of previous meetings but, all the same, each year it seems better than before. A new path accommodated three years ago on the east bank of the river, without spoiling the natural charm of the valley, is now used for our walk to the crags. It is a most enchanting ramble enhanced by the babbling of the water amid a variegated vegetation and a profusion of secular trees giving a refreshing shade, even in the warmest weather.

Much too soon we reached the stepping stones crossing the river to "Cosy Corner". Here we enjoyed a picnic lunch, washed down by excellent tea or minerals supplied by the conveniently situated Cosy Corner Café. Our hosts, Mr. and Mrs. Moor, and their charming daughter, Margaret, gave the feeling that they really like our coming, even though we monopolized their land, tables, benches and everything at hand for our convenience. We express gratitude for their solicitude, and we look forward to seeing them again next year.

At the "Landsgemeinde", started at about 2.30 p.m., we were joined by the Chairman of the Hepton Rural District Council, Councillor A. Howarth, and his wife, who welcomed us to their territory. Councillor Wilcox and Mrs. Wilcox also came over from Hebden Bridge to attend the ceremony.

The proceedings at the "Landsgemeinde", conducted by Professor Jean P. Inebnit, began with the singing in unison of "Le Vieux Chalet" (Abbé Bovet). This was followed by a concise history of the formation of Switzerland, from 1291 to 1815. As this proceeded, as only Professor Inebnit can do it, with skill and wit, starting with Uri, Schwyz and Unterwald, that is in 1291, and ending with Geneva, in 1815, the respective cantons, represented by the participants from these cantons, entered the circle. Thus we could see Switzerland growing in number. Some chose to sing a melody from their particular canton. Finally, friends of Switzerland from France, Germany, Austria

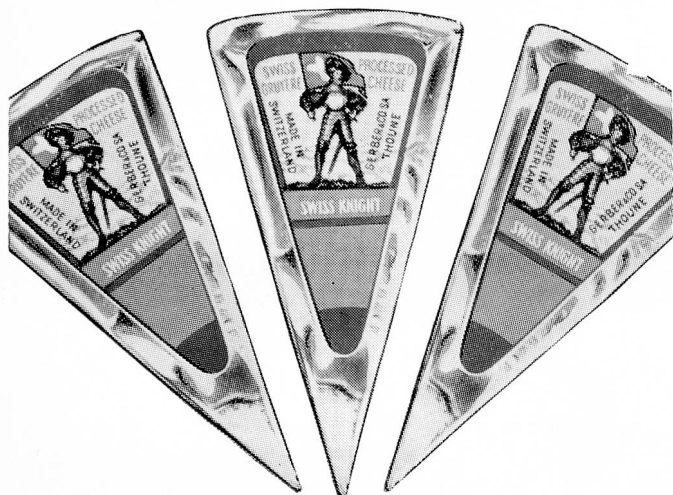

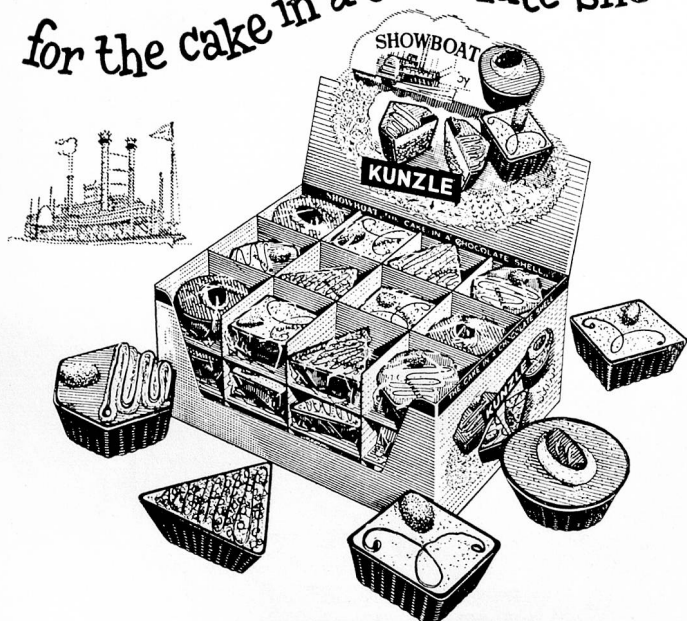
