THE TOWN OF GENEVA PRIZE

The prestige of the Town of Geneva Prize for Watchmaking, Jewellery, Goldsmith's Work and Enamel Work stands so high at present that this year 196 competitors submitted over one thousand projects to the jury, who chose about fifty for final execution. At the end of September, the jury made their final selection of prizewinners based this time on the finished works. They awarded the Town of Geneva Prize for Watchmaking (ladies' handbag watch: 244 projects entered, 17 selected for execution) to Mr. Jean-Claude Gueit of Ponti Gennari Co. Ltd. in Geneva, the prize for Goldsmith's Work (brooch without brilliants: 540 entries, 31 selected for execution) to Mr. Rudolph Gloor of Lévy Hermanos in Manila (the Philippines), the prize for jewellery (ear-rings: 318 entries, 18 selected) to Mr. Hans Stalder of Baar and Zurich. In the Enamel Work section (46 entries, 8 selected) no prize was awarded but two honourable mentions went to Mr. Willy Aeschlimann of Jean Humbert & Co. at La Chaux-de-Fonds. The items executed, i.e. those selected to take part in the finals, were displayed at the "Montres et Bijoux" exhibition held at the Rath Museum in Geneva from 7th to 29th October. It should be added that all these pieces, even those that did not win prizes, are of an exceptionally high artistic standard; the high quality is due to the international fame of the Town of Geneva Prize, which attracts creative artists from all over the world, as well as to the fact that the entries are very carefully considered by the jury who only select a small number for final execution.

HOLIDAYS FOR SWISS CHILDREN FROM

ABROAD

Over 650 Swiss children from abroad again spent holidays in Switzerland thanks to the Foundations "Pro Juventute" and "Schweizerhilfe". From the U.K., a party of 25 children left for Switzerland on 24th July and returned on 2nd September. As in recent years, they were in charge of Mr. and Mrs. Kaluza. The group consisted of 16 "Pro Juventute" children, 12 of whom came from Manchester, and 9 children who joined the party for travelling only, but who spent their holidays independently. The others were cared for either by private families or joined camps.

The scheme offers a splendid opportunity to young Swiss children to get to know their country, and a debt of gratitude is owed to Mrs. B. Kaluza who devotes much time and effort to this undertaking. She follows in the footsteps of other Swiss living in this country, who did the work before her (Mrs. E. Ribi, Mrs. W. Renz and the late Mrs. A. Boller, not to forget Mr. Ziereisen, formerly of the Swiss Benevolent Society, and his late wife who assisted the organisers).

The Swiss Benevolent Society again helped by paying the fares for those children unable to afford them, four of them this year.
